

ORDINANCE NO. 2017-01

AN ORDINANCE REPEALING ORDINANCE NO. R2011-9 PROVIDING FOR BUILDING PERMIT FEES AND PENALTIES FOR VIOLATIONS THEREOF AND FOR OTHER PURPOSES

BE IT ORDAINED BY THE CHEROKEE VILLAGE CITY COUNCIL THAT:

SECTION 1: ORDINANCE NO. R2011-9 IS HEREBY REPEALED IN ITS ENTIRETY.

SECTION 2: The City of Cherokee Village, Arkansas establishes the following permit fee schedule:

SECTION 3: SCHEDULE OF COSTS

(a) The schedule of costs shall be posted in the office of Planning & Zoning and may be altered, changed or amended by the Planning Commission and presented to the City Council for approval.

(b) There will be a thirty dollar (\$30) charge for each additional inspection over the required number of inspections for a given job.

(c) No permit shall be issued unless or until such costs, charges, or expenses have been paid in full, nor shall any action or construction proceed before the approval of the Planning Commission and until such costs and charges have been paid in full.

SECTION 4: PENALTIES. Violation of the provisions of this ordinance or failure to comply with any of its requirements shall constitute a misdemeanor. After the expiration date indicated by the notice of violation, any person, firm or corporation who violates this ordinance or fails to comply with any of its requirements shall, upon conviction thereof, be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than thirty (30) days, or both, and in addition shall pay all costs and expenses involved in this case. After the expiration date indicated by the notice of violation, each day such violation continues shall be considered a separate offense.

SECTION 5: SEVERABILITY. If any part of this ordinance shall be held to be invalid, such part shall be deemed severable and the invalidity thereof shall not affect the remaining parts of the ordinance.

The attached Ordinance is the ordinance that will repeal the current Building Permit Fees. This is the reason:

Current Zoning Code Ordinance has a charge of \$250 to cover rezoning.

Current Zoning Code Ordinance has a charge of \$25 to cover special permit fee.

On the advice of city attorney these fees should be listed in our permit fees.

Additional I have added; deck replace to original size, windows, doors, gutters, steps and driveway. These activities require a permit but the fee is \$0 and should be listed.
