

**RESOLUTION NO. 2008-16**

**RESOLUTION TO ORDER THE RAZING AND REMOVAL OF A NUISANCE  
ON THE PROPERTY LOT 12, BLOCK 5, CHOCTAW 1<sup>ST</sup> ADDITION,  
CHEROKEE VILLAGE SUBDIVISION, SHARP COUNTY, ARKANSAS**

**BY THE CITY OF CHEROKEE VILLAGE,  
SHARP AND FULTON COUNTIES, ARKANSAS**

WHEREAS, the City Council of the City of Cherokee Village, Arkansas, having met in session on the 18<sup>th</sup> day of December 2008, to hear the testimony and evidence presented on the issue of the unfinished building on the property Lot 12, Block 5, Choctaw 1<sup>st</sup> Add. Cherokee Village, Sharp County, Arkansas, owned by Mr. Edgar Hajinyan, 462 Riverdale Drive, #102, Glendale, CA 91204, and

WHEREAS, the owner of the property has been duly notified of the hearing and had an opportunity to be heard and offer evidence on his or her behalf, and

WHEREAS, the owner of the property has caused to be constructed on the property a foundation, and

WHEREAS, the owner of the property has failed to construct a building on the property using the foundation constructed on the property, and

WHEREAS, all applicable building permits on the property have expired and not been renewed, and

WHEREAS, the existence of an unfinished structure on property within the corporate limits of the City of Cherokee Village, Arkansas, constitutes a nuisance as defined in Ordinance No. 2008-05;

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Cherokee Village, Arkansas, with the approval of the Mayor, that the City of Cherokee

Village, Arkansas, shall order the razing and removal of the foundation on the property,  
and


Such order shall be transmitted to the owner of the property giving the owner  
thirty (30) days to comply with the raze and remove order, and

In the event the owner of the property fails to raze and remove the foundation  
within thirty (30) days, the City shall enforce the order by razing and removing the  
foundation and asserting a lien against the property for the costs of such razing and  
removal, such lien to be enforced as the law permits.


Re: Lot 12, Block 5, Choctaw 1<sup>st</sup> Add., Cherokee Village, Sharp Co., Arkansas

Dear Mr. Hajinyan,

Pursuant to resolution of the City Council of the City of Cherokee Village, Arkansas, dated December 18, 2008, and their statutory authority, you are hereby ordered to raze and remove the foundation on your property, Lot 12, Block 5, Choctaw 1<sup>st</sup> Add., Cherokee Village, Sharp Co., Arkansas, within thirty (30) days of the date above.

If you fail to remove the foundation and return the property to its natural contour and vegetation within the time allowed, the city shall cause the foundation to be removed, the property returned to its natural state, and assert a lien against the property to recover the costs incurred. The lien will then be collected as provided for by law.
